# **GOVERNMENTAL NEWS**

#### **ARKANSAS**

ACT 753 OF 1991

"AN ACT TO PROHIBIT THE DESECRATION OF HUMAN SKELETAL BURIAL REMAINS IN UNREGISTERED CEMETERIES; TO PROHIBIT TRADE OR COMMERCIAL DISPLAY OF HUMAN SKELETAL BURIAL REMAINS OR ASSOCIATED BURIAL FURNITURE; AND FOR OTHER PURPOSES."

Act 753 of 1991 prohibits the desecration of human remains in unregistered cemeteries and the trade or commercial display of remains or associated burial artifacts. The Act applies to <u>all</u> human remains, whether on private or public property, land or water.

Through Act 753, the Arkansas General Assembly intends that all human remains, regardless of ethnic origin, cultural background, religious affiliation, or date of burial or disposal should receive equal treatment and respect for human dignity.

Archaeologists doing research in Arkansas should adhere to the following procedures when dealing with human burial remains:

 Under Section 7 of Act 753, archaeologists must justify projects that will encounter burials or have the potential to encounter burials by sending to the State Historic Preservation Officer a copy of the research design or mitigation plan for the project. The justification must show that the archaeologist has the consent of the landowner to excavate on the property and that the project archaeologist is employed by the State of Arkansas or the United States government, or meets the U.S. Department of Interior's professional qualifications as found in the current Code of Federal Regulations. An Acknowledgement will be made in writing.

- If human remains are encountered, the archaeologist must notify the State Historic Preservation Officer, who will assist with the consultation process indicated in Section 7, of Act 753.
- The disposition of any human remains must follow procedures in Sections 8 and 9 of Act 753.
- Scientific recovery and forensic studies should be conducted according to Appendix K of "A State Plan for the Conservation of Archaeological Resources in Arkansas."
- One copy of the final report should be filed with the library of the Arkansas Archaeological Survey and one with the Arkansas Historic Preservation Program.

In 1990, amendments were passed to the 1973 state law protecting historic, archaeological and paleontological resources. The amendments clarified language in the original law, provided guidelines for arranging out-of-state loans of collections, and detailed procedures for discoveries of unmarked human graves. Regulations also were recently passed implementing the 1975 State Register of Historic

Places Act and, in 1990, a State Preservation Tax Credit law was passed (it necessitated finalizing the regulations for the State Register Act). Submitted by Kevin Black, Assistant State Archaeologist.

# **MINNESOTA**

In 1991 the Minnesota SHPO renewed efforts to continue the Statewide Archaeological Survey initiated in 1977. The survey, which was suspended in 1981 due to budget cuts, have identified and recorded hundreds of sites in various counties throughout the state.

Last year, the SHPO sponsored an archaeological survey of Traverse County. Results of the survey identified 35 new sites and reexamined 30 previously recorded sites. Most sites had a Late Prehistoric affiliation (ca. A.D. 900-1700), while a few recovered materials were affiliated with Early Prehistoric components. According to *The Minnesota Preservation Planner*, "The Late Prehistoric sites are particularly interesting as they demonstrate cultural linkages between Minnesota's woodlands and the Great Plains. The Plains Village culture of western Minnesota features stockaded villages where corn growing peoples probably had substantial houses. The outlines of the fortification trenches at several Traverse County sites can still be seen."

The ASC is only one of three authorized curatorial facilities in Kentucky, housing primarily cultural materials from western and west-central Kentucky. ARCHAEOLOGICAL SITE STABILIZATION WORKSHOP

May 11-15, 1992 VANCOUVER, WASHINGTON

The Pacific Northwest Region of the National Park Service, in cooperation with NPS Southeast Regional Office and the national Clearinghouse for Archaeological Site Stabilization is offering a 40-hour workshop on archaeological site stabilization. This course will provide participants with an overview of archaeological site stabilization and preservation as a viable and cost-effective mechanism for resource management. This workshop is designed to familiarize the participants with the basic techniques of site stabilization through a combination of lectures and case history presentations. Through actual work on a selected site, participants will learn design requirements needed in the development of a site preservation program. Time will be provided for voluntary presentations and discussions of individual site stabilization problems. Students are invited to show up to five slides when making this presentation.

The Division of Continuing Studies at the University of Mississippi will provide four continuing education credit units to participants upon completion of the workshop. There will be no fees for these units and no tuition charge for the course.

# WORKSHOP REVIEWS

ODNR Division of Reclamation Second Education Forum on Archeology

The Ohio Department of Natural Resources Division of Reclamation sponsored its second educational forum on archeology for Ohio's mining industry and preservation community on March 18, 1992, at the Ohio University regional campus, Zanesville, Ohio. Over twenty surface- and underground-mining companies and several contracting

archeology firms attended the day-long forum.

The morning session was devoted to presentations by the Ohio Historic Preservation Office staff on the documentation of historic and prehistoric properties on Ohio Archeological and Historic Inventory forms for both the non-professional and professional preservationist. Avenues to reduce initial archaeology costs to industry also were explored.

The afternoon session focused on the findings of the task force committee on Archeological Investigations and special studies for an Industry Preliminary Report. The task force is made up of industry, preservation, and federal and state mining regulatory personnel. Several findings options were identified and presented to the audience to reduce or share costs of surveys, provide computerization of sites in Ohio's coal region, and develop an experiment in underground mining impacts to subsurface sites by the industry and the Office of Surface Mining and Division of Reclamation. A

formal report with recommendations will be submitted to the Chief of the Division of Reclamation in mid-April, 1992.


