## **State News**

## Alaska

The Alaska Historical Commission met November 14, 1996, in Anchorage. Among the items on the agenda was a demonstration and discussion of the statewide inventory of sites, buildings, and structures, known as the Alaska Heritage Resources Survey (AHRS). Commission members endorsed the Office of History and Archaeology's efforts to get additional funding to alleviate the backlog and encouraged staff to investigate moving the inventory to a Geographic Information System. Commission members reviewed several geographic name proposals and approved one, Cutthroat Creek, in southeast Alaska. Members also discussed several threatened historic properties, among them Creamer's Dairy barns in Fairbanks, Nike Site Summit in Anchorage, the coal bunkers in Fairbanks, and the Matanuska Colony cannery-creamery building in Palmer.

## Kentucky

14th Annual Kentucky Heritage Council Archaeological Conference

The 14th Annual Kentucky Heritage Council (KHC) Archaeological Conference was held March 14-16,1997, at Natural Bridge State Park, located on the edge of the Daniel Boone National Forest in the Red River Gorge area of east-central Kentucky. The conference was co-hosted by the KHC and the Daniel Boone National Forest. Activities began on Friday afternoon with a brief overview of the archaeology of the Red River Gorge area followed by a walking (climbing?) tour of rockshelters in the area. Tours were guided by Forest Service archaeologists Cecil Ison and Johnny Faulkner.

Saturday began the paper presentations, which continued through noon on Sunday. David Pollack of the KHC served as M.C. Nineteen of 21 scheduled papers were presented, covering topics ranging from the Paleoindian period to the recent past, and most periods in between. Several papers dealt with the environs of the Red River Gorge area, with three papers on rockshelters and two papers dealing with historic utilization of the area (millstone quarrying and splash dams).

Three papers dealt directly with public archaeology and the use of volunteers. In one case, fourth graders conducted much of the fieldwork at a site in Greenup County, and in another case, the Clay County High School Anthropology Class not only conducted the investigations, cleaned and analyzed the artifacts, but they also presented the paper.

## **Great Lakes Public History Workshop**

Remote sensing at a site, a countywide survey of mounds, and a study of prehistoric textiles augmented the survey and site testing reports. Papers on historic archaeology included the aforementioned studies of millstone quarrying and splash dams, as well as archaeology at a house museum site, among others.

Not all topics related to Kentucky, and not all paper presenters were from the state, as Ohio, Indiana, Illinois, and Missouri were represented among those presenting papers. Presenters represented state agencies, federal agencies, universities, and private consulting firms. Several papers represented work conducted by the Kentucky Archaeological Survey, a joint venture of the KHC and the University of Kentucky.

Selected papers from the conference will be published by the KHC in their Current Research in Kentucky series. Both the KHC and the Daniel Boone National Forest should be commended for conducting such a successful conference.

## Maine

In September, the U.S. Senate approved legislation permitting the U.S. Coast Guard to transfer 36 of Maine's 64 working lighthouses to other agencies better able to provide for their long-term maintenance and preservation. First priority in the disposition of the lighthouses will fall to other federal agencies, followed by the state and towns, and finally by private groups, including non-profit organizations, educational agencies or community development corporations. The federal government will transfer title, free of charge, of a particular lighthouse for a period of 30 years, with the recipient charged with the responsibility of maintianing the building(s) and grounds and assuring public access to the site. The Coast Guard will maintain control of the actual lights and foghorns, and Page 4

will make periodic inspections of the property to insure compliance by the new occupant.

The creation of the Maine Lights Program, as it is now called, was spearheaded by Peter Ralston, vice president of the Island Institute. #### Montana

The Society for American Archaeology (SAA) has awarded \$12,000 in grants to the Montana Historical Society as part of a multi-year project developed by SAA's Public Education Committee in partnership with the Bureau of Land Management, the Bureau of Reclamation, and the National Park Service Archeology and Ethnography Program. Grants are awarded in an effort to extend SAA's

network of volunteer archaeology education coordinators, who will put teachers and other interested member of the public in touch with sources of information about archaeology. Mark Baumler, Montana's state archaeologist, and Marcella Walter, Montana Historical Society education officer. will serve as joint coordinators of the Montana Ancient Teachings Education Project. This program will prepare educational materials, train archaeologists and educators, and develop online databases of archaeology education resources for teachers. ## New Jersey

The New Jersey Historic Preservation Office (HPO) has received an award of \$574,037 from the New Jersey Department of Transportation and the Federal Highway Administration's Intermodal Surface Transportation Enhancement Act (ISTEA) funds to develop a Geographic Information System for cultural resources. This project was among 45 projects recommended by the Enhancement Evaluation Committee from among 226 applications, requesting \$122 million.

The money will be used to develop data layers to input existing archaeological and architectural survey data for two counties, Gloucester and Salem, as a pilot development project. Using the Global Positioning System, the project will include a comprehensive survey of Salem County. Located within the New Jersey Department of Environmental Protection, the Historic Preservation Office will coordinate with the existing land use data base system. This pilot project will enable the HPO to project time and cost factors to digitize the entire state's cultural resource information.

Easy accessibility of cultural resource information can effectively streamline the regulatory process and assist in predictability during project planning.

The HPO will establish an Advisory Committee from coordinating agencies which will ensure policy consistency throughout this project.

## South Carolina

CHARLESTON, SC — A S.C. couple has filed suit in U.S. District Court today challenging the U.S. Army Corps of Engineers authorization of a Nationwide Permit to the County of Charleston for roadway construction through wetlands on property known

as "the Sheppard Tract."

Oak Hall Plantation owners Russ and Lee Pye have filed suit, alleging the Corps authorization violated provisions of the National Historic Preservation Act, the National Environmental Policy Act, and the Endangered Species Act.

Charleston County officials chose a historic 750-acre rice plantation south of Charleston, near the pristine Edisto River (part of the federally funded ACE Basin Project, for a proposed hazardous ash monofil landfill site. The plantation has documented archaeological and cultural resources and is habitat to endangered species. More than half of the site, former rice fields of the plantation, is considered wetlands. The property's only access is by a 50 foot right-of-way off U.S. Highway 17 requiring wetlands fill for road construction.

Area residents became concerned when they learned permits issued for this project failed to consider, among other things, the historical significance of the area and the environmental impacts to the adjacent wetlands.

The U.S. Fish and Wildlife Service, when asked to comment on the undertaking, recommended that an environmental assessment be conducted on the entire 750-acre site, rather than considering only the proposed wetland crossing, with particular attention given to potential impacts to endangered species. The suit alleges that the Corps permit is a federal undertaking that would significantly alter the human environment and the Corps failed to prepare an environmental impact statement as required by law.

Additionally, the Advisory Council on Historic Preservation had contacted the Corps regarding the Corps responsibilities to identify and assess impacts on historical properties. Despite those concerns, the Corps authorized the road construction under their Nationwide Permitting authority, citing the U.S. Army Corps of Engineers' South Atlantic Division memorandum ("Sanders Ruling") that prohibits consideration of historical and natural resources when they may be located outside the "footprint of the project site." However, with the only legal access to the property requiring

the federal permit, development of the property cannot occur but for the federal involvement.

The suit challenges the Corps of Engineers as having implemented guidelines that are contrary to public law and petitions the court for declaratory relief. This matter should be of particular interest to cultural resource management professionals and environmentalists who wish to see the U.S. Army Corps of Engineers' Nationwide permit program comply with historic preservation and environmental laws.

#### Texas

Reviewers at The Texas Historical Commission (THC), Division of Antiquities Protection (DAP) have been shorthanded since the first of September, due to the loss of two key personnel, Sergio Iruegas and Tim Perttula. Consequently, DAP has experienced some difficulty keeping within their 30-day limit for responding to requests for reviews. However, considering, the loss of manpower, the review staff has done an exceptional job, completing most reviews quite rapidly.

Current database figures indicate that the average THC response time is 7.2 working days, and only 1.8 percent of reviews have taken longer than 30 days to complete. When these figures are compared with those for the same period in 1995 (7.4 days and 1.1%) it is clear that DAP reviewers have been working very hard to respond in a timely manner.

As soon as DAP realizes that a review cannot be completed within 30 days, they write a letter requesting an extension. DAP asks that everyone please bear with them until they can bring their staff level back up.

## **Publications**

## Down By The Station: Los Angeles Chinatown 1880-1993.

Down By the Station, summarizes historical research, fieldwork, and laboratory analysis, as it provides an unprecedented window into the Chinese American experience and the cultural life of people living in the Los Angeles Chinatown in the late nineteenth and early twentieth century. Within the excavated area, numerous cultural features were identified and sampled. The assemblage of material objects reflects the import, preparation, and service of food; recreation; health practices; the presence of women and children; rubbish disposal practices; and a degree of participation in local social networks.

The book begins by presenting

the historical and geographical context of the Los Angeles Chinese community once it had taken root on previously vacant land utilized almost entirely for agriculture and its persistence as an intact community until its demolition which sealed the remains below many feet of sterile fill.

The archaeological context from which the material objects were recovered is described next, followed by the data derived from the recovery program. These findings are grouped in chapters to illuminate the full picture of life as it was lived by Chinese American people in the Los Angeles Chinatown between 1880 and 1933. The concluding chapter synthesizes the contributions of this project to our understanding of life ways that have disappeared, often without adequate or accurate documentation.

We have made arrangements for the programming and design of the website but we need help creating and gathering content. The website will include Civil War history, travel and tourism, and information on battlefield preservation. Writing skills are especially important.
