Aerial Photo Library

Many people who do historical and archaeological research in New Jersey are not aware that NJ Department of Environmental Protection has a comprehensive aerial photo library available for public use in Trenton just a few doors down from the Historic Preservation Office.

The earliest available aerial photos cover coastal areas of the State and date to 1932-36. Photo

coverage of the entire state dates to 1940, and was again accomplished in 1951, 1953-54, 1961, 1972, 1974, 1986, and 1991. Many coastal, tidal, and other areas are also variously represented in 1947, 1956-57, 1958, 1971-72, 1977-78, and 1979.

The Pinelands was also 'flown' in 1977. Older photographs are black and white, while more recent ones are either color or infrared. The scale of the photographs is generally between 1:12,000 and 1:20,000.

Official Historic Texas Cemetery Desigantion

In an effort to document the approximately 50,000 historic cemeteries in the state, the Texas Historical Commission has launched the Official Historic Texas Cemetery designation. Individuals and groups are encouraged to apply for cemetery designations by showing proof that a cemetery is at least 50 years old, giving its exact location, and paying a \$25 processing fee. Nature of Work: This is a professional position within the Resource Protection and Reviews Department of the Ohio Historic Preservation Office of the Ohio Historical Society. Work is carried out under the direction of the department head.
